# Trevor Leo Medal

## Eligibility and conditions of entry

#### Eligibility

The Trevor Leo Medal is awarded to an individual who has made an outstanding contribution to the vocational education and training and skills sectors in Tasmania and/or nationally over a sustained period (at least 15 years).

The Award is named in honour of Mr Trevor Leo who made an enormous contribution to Tasmania's and Australia's education and training sector for over 50 years. Trevor Leo was a recipient of the inaugural award in 2009. The Award recipient will receive a unique Medal designed exclusively for the Tasmanian Training Awards.

Nominees must be an Australian citizen or a permanent resident of Australia, and reside in Tasmania

This Award aims to recognise individuals who:

- have an established history of distinguished service to the vocational education and training (VET) and skills sectors (at least 15 years)
- have made a lasting contribution to VET and skills sectors practice
- can provide evidence of the provision of leadership and inspiration to others
- can provide examples that show positively influenced VET and skills development, on a state, national or international level.

Selection of the recipient is made on the basis of the candidate's significant, fundamental contributions to the VET and skills sectors, whether in research, leadership, mentorship or other; the lasting impact of these contributions to the sectors; and the demonstration of a long-term commitment to VET and skills development.

Note: The recipient of the 2025 Trevor Leo Medal may be eligible to be nominated for the 2026 Australian Training Awards' *Outstanding Achievement in the VET and Skills Sector Award.* 

#### Conditions of entry

To be considered for the Medal the following conditions of entry must be met:

- Individuals cannot self-nominate. However, once nominated the nominee may write the application.
- Nominees must be eligible for entry according to the eligibility criteria. Non-compliance with entry criteria will be sufficient reason for Skills Tasmania to reject the nomination.
- Nominees must be able to attend a gala presentation dinner on Friday, 19 September 2025 in Hobart.
- Nominees and nominators must agree to abide by the decision of the Skills Tasmania judging panel. All matters relating to the awards shall be final and no appeals will be entered into.
- By entering the Awards, nominees, nominators and recipients agree that Skills Tasmania may use non-confidential details, profiles, and photographs for any publicity or promotional purpose pertaining to vocational education and training and workforce development including, but not limited to, the Tasmanian Training Awards.

### **Nomination Process**

#### Preparing a nomination

To nominate an individual for this Award, the nominator will:

- check with the nominee to ensure they willingly accept the nomination and is available to attend the gala presentation dinner if they are the recipient of the Trevor Leo Medal
- · complete the nomination form
- address the three selection criteria. The nominator or nominee may write the application
- add a statement supporting your nomination of the candidate.

The information provided in the nomination form and selection criteria will be used to inform further investigations of the candidate's suitability for the Award and to inform the judging panel's decision.

#### Lodging the nomination

- We will send you written confirmation on receipt of the nomination.
- In lodging the nomination, you are confirming it complies with the eligibility criteria and that you agree to the conditions of entry.

Provision of this information is essential to determine eligibility and consideration for an award. The information will be stored securely.

#### Next steps

Nominations are assessed by a Skills Tasmania Panel and a shortlist of candidates is referred to the Minister for Skills and Training for his selection of the award winner. Nominees are notified if they have been selected as the recipient of the Medal. The recipient is invited to attend the Tasmanian Training Awards Presentation ceremony in Hobart on Friday, 19 September 2025.

Criterion 2: Significant contributions to and positive influence on the VET and Skills sectors

Criterion 3: Leadership

This information will be considered and used for assessment purposes. Please be aware that your responses to the selection criteria will be strengthened by the inclusion of measurable results and appropriate indicators (including achievement data and other types of external validation).

Up to three (3) single A4 pages of relevant evidence may be provided for each criterion as an attachment. These attachments may be used to highlight a point made in your response and should be clearly referenced within the criterion response.

Note: considerations are not additional selection criteria, but are provided to clarify what may be relevant to include when writing a response for each criterion.

### **Criterion 1: History of Service**

(limit 800 words)

Consider the nominee's history of service to the VET and skills sector—in particular, positions of leadership the nominee has held such as on boards or as chairs of committees. Any other known history in the sector, such as participation on committees and working groups, and any examples of the nominee representing the VET and skills sector officially as a liaison to other organisations or at state, national or international meetings. Additionally, consideration is given to an individual's broader contributions to the VET and skills sector.

# Criterion 2: Significant contributions to and positive influence on the VET and skills sector

(limit 800 words)

Consider the nominee's significant contribution(s) to the advancement of VET practice and skill development, including teaching or training positions or programs, awards or recognition from professional or industry groups and institutions, and/or innovative approaches to difficulties. How will the nominee's story inspire others to higher standards in their work or to raise the communities' perception of the VET and skills sector?

#### **Criterion 3: Leadership**

(limit 800 words)

The nominee's leadership in the field of VET and skills including, but not limited to, positively influencing policy or practice on a state, national or international level. This may include Government committees and workgroups, advocacy, senior positions, other training, mentoring or committee participation. How have they 'made a difference' in some way?
